WHEREAS, the BIDS AND AWARDS COMMITTEE passed BAC Resolution No. 19-0982 series of 2019 re: BAC Resolution Declaring 2nd Failure of Bidding and Recommending Procurement through Negotiated Mode; and was duly approved by the Honorable Governor, authorizing the use of the such Method of Procurement by the PROVINCIAL GENERAL SERVICES OFFICE in undertaking Procurement Request under PR No. 2019-0815 re: Procurement of Hardware & Plumbing Materials for the Repair & Replacement of Worn-out Parts of the PGBh Building & Facilities by the Provincial General Services Office, Tagbilaran City, with an ABC of P 354,190.00.



WHEREAS, upon careful examination, validation and verification of the accreditation and other pertinent documents, including the price quotation offered, to determine its eligibility to transact business with the provincial government and the responsiveness of its bid and as provided for under paragraph a of Section 53.1 of the Implementing Rules and Regulations of R.A. 9184, R&A CONSTRUCTION & SUPPLY has been found to be ELIGIBLE and its bid, RESPONSIVE;

NOW, THEREFORE, We, the Members of the Bids and Awards Committee, hereby RESOLVES, as it is hereby RESOLVED:

- a). To declare R&A CONSTRUCTION & SUPPLY as the supplier with the Lowest and Responsive Price Quotation for the Delivery of Goods/Services under Negotiated Canvass No. 19-0514 (2nd Failure);
- b). To recommend award to R&A CONSTRUCTION & SUPPLY or delivery of goods/services under Negotiated Canvass No. 19-0514 (2nd Failure) in the amount of P 351,970.00;
- c). To recommend for approval by the HONORABLE GOVERNOR of the PROVINCIAL GOVERNMENT OF BOHOL the foregoing findings.
