WHEREAS, the BIDS AND AWARDS COMMITTEE passed BAC Resolution No. 19-1023 series of 2019 re: BAC Resolution Declaring 2nd Failure of Bidding and Recommending Procurement through Negotiated Mode; and was duly approved by the Honorable Governor, authorizing the use of the such Method of Procurement by the BOHOL PROVINCIAL LIBRARY & INFORMATION CENTER in undertaking Procurement Request under PR No. 2019-0883 re: Procurement of Various Books/Publications/Learning Materials for the use at Bohol Provincial Library & Information Center, Tagbilaran City. with an ABC of ₱ 369,895.98;

WHEREAS, canvass of prices done in the course of the Negotiated Method of Procurement showed that LINAR EDUCATIONAL MATERIALS INC. offered the lowest price quotation among the suppliers as reflected in the Abstract of Bid Quotation;
