WHEREAS, the **PROVINCIAL ENGINEER'S OFFICE** of the PROVINCIAL GOVERNMENT OF BOHOL made procurement of goods under Purchase Requests No. 2020-0146 re; Procurement of Hardware & Painting Materials for the General Repair of Monte Video Bridge at Guadalupe-Monte Video Road, Carmen, Bohol, by the Provincial Engineer's Office, New Capitol Compound, Tagbilaran City. with an ABC of P 265,889.00;

WHEREAS, canvass of prices done in the course of the Negotiated Method of Procurement showed that **CLAVITE ENTERPRISES & CONSTRUCTION SUPPLY** offered the lowest price quotation among the suppliers as reflected in the Abstract of Bid Quotations;


NOW, THEREFORE, We, the Members of the Bids and Awards Committee, hereby RESOLVE, as it hereby RESOLVED:


