WHEREAS, the **Provincial Motor Pool Office** of the PROVINCIAL GOVERNMENT OF BOHOL made procurement of goods under Purchase Requests No. **2020-0283**; re; **Procurement of Vehicle Spare Parts, by the Provincial Motor Pool Office, New Capitol Site, Tagbilaran City.** with an ABC of **P 144,300.00.**

NOW, THEREFORE, We, the Members of the Bids and Awards Committee, hereby RESOLVE, as it hereby RESOLVED:


