WHEREAS, the BIDS AND AWARDS COMMITTEE passed BAC Resolution No. 20-0199 series of 2020 re: BAC Resolution Declaring 2nd Failure of Bidding and Recommending Procurement through Negotiated Mode; and was duly approved by the Honorable Governor, authorizing the use of the such Method of Procurement by the OFFICE OF THE VICE GOVERNOR in undertaking Procurement Request under PR No. 2019-0765 re: Procurement of Various Vehicle Parts, Gear Oil, Engine Oil, Silicon & Tires, by the Office of the Vice Governor, New Capitol Compound, Tagbilaran City, with an ABC of P 307,410.00.

WHEREAS, canvass of prices done in the course of the Negotiated Method of Procurement showed that 200 M AUTO REPAIR SHOP & PARTS, Offered the lowest price quotation among the suppliers as reflected in the Abstract of Bid Quotation;


