

WHEREAS, the OFFICE OF THE GOVERNOR of the PROVINCIAL GOVERNMENT OF BOHOL made procurement of goods under Purchase Requests No. 2020-0156; re; Procurement of Community Billboard (Tarpaulin Fabric) by the Office of the Governor, New Capitol Compound, Tagbilaran City. with an ABC of P 193,600.00

WHEREAS, canvass of prices done in the course of the Negotiated Method of Procurement showed that CENTROID PRINTSHOP offered the lowest price quotation among the suppliers as reflected in the Abstract of Bid Quotations;
