BAC Resolution Recommending Procurement thru Negotiated Method Resulting from the Second Failure of Bidding, Declaring LCRQ and Recommending Award

WHEREAS, the BIDS AND AWARDS COMMITTEE passed BAC Resolution No. 20-0314 series of 2020 re: BAC Resolution Declaring 2nd Failure of Bidding and Recommending Procurement through Negotiated Mode; and was duly approved by the Honorable Governor, authorizing the use of the such Method of Procurement by the OFFICE OF THE PROVINCIAL ENGINEER in undertaking Procurement Request under PR No. 2019-0914 re: Procurement of Rescue Vehicle & Mini Dump Truck Vessel with an ABC of ₱ 4,600,000.00

WHEREAS, canvass of prices done in the course of the Negotiated Method of Procurement showed that NISSAN CEBU DISTRIBUTORS INC. & AVANTRAC HEAVY MACHINERY INC. offered the lowest price quotation among the suppliers as reflected in the Abstract of Bid Quotation;

WHEREAS, upon careful examination, validation and verification of the accreditation and other pertinent documents, including the price quotation offered, to determine its eligibility to transact business with the provincial government and the responsiveness of its bid and as provided for under paragraph a of Section 53.1 of the Implementing Rules and Regulations of R.A. 9184, NISSAN CEBU DISTRIBUTORS INC. & AVANTRAC HEAVY MACHINERY INC. has been found to be ELIGIBLE and its bid, RESPONSIVE;

NOW, THEREFORE, We, the Members of the Bids and Awards Committee, hereby RESOLVES, as it is hereby RESOLVED:

- a). To declare NISSAN CEBU DISTRIBUTORS INC. as the supplier with the Lowest and Responsive Price Quotation for the Delivery of Goods/Services for Item # 1 while item # 2 is recommended for AVANTRAC HEAVY MACHINERY INC. under Negotiated Canvass No. 20-0007 (2nd Failure);
- b). To recommend award to NISSAN CEBU DISTRIBUTORS INC. for the delivery of goods/services for item # 1 in the amount of ₱ 1,675,000.00 while item # 2 is recommended for AVANTRAC HEAVY MACHINERY INC. under Negotiated Canvass No. 20-0007 (2nd Failure) in the amount of ₱ 2,900,000.00
- c). To recommend for approval by the HONORABLE GOVERNOR of the PROVINCIAL GOVERNMENT OF BOHOL the foregoing findings.
