

BAC Resolution Recommending the Use of Negotiated Procurement through Small Value, Declaring Lowest Calculated and Responsive Quotation and Recommending Approval

RESOLUTION NO. 20-0569 Series of 2020

WHEREAS, the <u>PROVINCIAL ENGINEER'S OFFICE</u> of the PROVINCIAL GOVERNMENT OF BOHOL made procurement of goods under Purchase Request No. <u>2020-0380</u>, re; <u>Procurement of Hardware & Construction Supplies for the General Repair of Sapang Gamay Bridge at Guadalupe, Carmen, Bohol, by the Provincial Engineer's Office, New Capitol Compound, Tagbilaran City. with an ABC of <u>P 349,552.50</u>;</u>

WHEREAS, canvass of prices done in the course of the Negotiated Method of Procurement showed that <u>A&D</u> <u>CONSDTRUCTION AND SUPPLY</u> offered the lowest price quotation among the suppliers as reflected in the Abstract of Bid Quotations;

WHEREAS, under Section 53.9 of the IRR of R.A. 9184 and upon careful examination, validation and verification of the accreditation and other pertinent documents of <u>A&D CONSDTRUCTION AND SUPPLY</u> including the price quotation offered, to determine its eligibility to transact business with the Provincial Government and the responsiveness of its bid <u>A&D CONSDTRUCTION AND SUPPLY</u> has been found to be ELIGIBLE and its bid, RESPONSIVE;

NOW, THEREFORE, We, the Members of the Bids and Awards Committee, hereby RESOLVE, as it hereby RESOLVED:

- a.) To declare <u>A&D CONSDTRUCTION AND SUPPLY</u> as the bidder with the LOWEST CALCULATED AND RESPONSIVE BID/for the DELIVERY OF GOODS/SERVICES under Negotiated Canvass No. <u>2020-0271</u>;
- b.) To recommend award to <u>A&D CONSDTRUCTION AND SUPPLY</u> for the delivery of goods/services under Negotiated Canvass No. <u>2020-0271</u> in the amount of <u>P 349,547.50</u>;
- c.) To recommend for approval by the HONORABLE GOVERNOR of the PROVINCIAL GOVERNMENT OF BOHOL the foregoing findings.
