

WHEREAS, the **PROVINCIAL GOVERNMENT OF BOHOL** caused the advertisement and posting of Invitation to Bid in the Newspaper, PHILGEPS Website, Provincial Government Website and at three (3) conspicuous places in the premises of the Provincial Capitol Complex, Tagbilaran City of the hereunder project:

WHEREAS, in the detailed evaluation of bids INTEGRATED SCIENTIFIC & INDUSTRIAL SUPPLY. was declared as the **Lowest Calculated Bid** as Read in the amount of **P 181,170.00**.

WHEREAS, Based on the Post Qualification conducted by the Technical Working Group (TWG), INTEGRATED SCIENTIFIC & INDUSTRIAL SUPPLY failed to pass the post qualification process, for the reason:

*- Based on the evaluation conducted by TWG and upon consultation with the Laboratory head, Letter hereto attached, **INTEGRATED SCIENTIFIC & INDUSTRIAL SUPPLY** is disqualified due to non-responsive bid/non-compliant on the specifications/Type of Incubator Bottle required by the end-user. The said supplier offered an Incubator Bottle (KIMAX USA) while the end-user preferred an Incubator Bottle offered by **LABTRADERS INC.** based on the brochure attached, which is compliant to the specifications of the glassware needed by the Septage and wastewater Laboratory.*

WHEREAS, upon the conduct of post qualification by the Technical Working Group, LABTRADERS, INC. met the required legal, technical and financial requirements for the said project;

WHEREAS, upon recommendation by the Technical Working Group and verification, validation and ascertaining of all statements made and documents submitted by LABTRADERS, INC. the bidder declared as the **LOWEST CALCULATED BID**, successfully passed the Post Qualification process, thus the Committee now considered its bid as the **LOWEST CALCULATED and RESPONSIVE BID** for the said project;

**NOW THEREFORE**, We the Members of the Bids and Awards Committee, hereby **RESOLVE**, as it is hereby **RESOLVED**:
