WHEREAS, the **BIDS AND AWARDS COMMITTEE** passed BAC Resolution No. _____ series of 2020 re: BAC Resolution Declaring 2nd Failure of Bidding and Recommending Procurement through Negotiated Mode; and was duly approved by the Honorable Governor, authorizing the use of the such Method of Procurement by the **FRANCISCO DAGOHOY MUNICIPAL HOSPITAL, INABANGA, BOHOL** in undertaking Procurement Request under **PR No. - PHO - 2019 - 283** re: **PROCUREMENT OF BASIC LIFE SUPPORT AMBULANCE FOR EMERGENCY & DISASTER RESPONSE FOR TRANSPORTING MEDICAL PATIENT TO TREATMENT** with an ABC of **P 2,499,500.00**;

WHEREAS, canvass of prices done in the course of the Negotiated Method of Procurement showed that **MEDICAL GALLERY TRADING CO.** offered the lowest price among the suppliers as reflected in the Abstract of Bid Proposals;


WHEREAS, upon careful examination, validation and verification of the accreditation and other pertinent documents, including the price quotation offered, to determine its eligibility to transact business with the provincial government and the responsiveness of its bid and as provided for under paragraph a of Section 53 of the implementing Rules and Regulations of R.A. 9184, **MEDICAL GALLERY TRADING CO.** has been found to be **ELIGIBLE** and its bid, **RESPONSIVE**;


NOW, THEREFORE, We, the Members of the Bids and Awards Committee, hereby **RESOLVE**, as it hereby **RESOLVED**:

- a. To declare **MEDICAL GALLERY TRADING CO.** as the supplier with the Lowest and Responsive Price Quotation for the Delivery of Goods under **Negotiated Canvass No. - PHO - 19 - 160 (2nd failure of bidding)**;
- b. To recommend award **MEDICAL GALLERY TRADING CO.** for the Delivery of Goods under **Negotiated Canvass No. - PHO - 19 - 160 (2nd failure of bidding)** in the amount of **TWO MILLION FOUR HUNDRED NINETY NINE THOUSAND FIVE HUNDRED PESOS ONLY (P 2,499,500.00)**;
- c. To recommend for approval by the **HONORABLE GOVERNOR** of the **PROVINCIAL GOVERNMENT OF BOHOL** the foregoing findings.




