

BAC Resolution Recommending the Use of Negotiated Procurement through Small Value, Declaring Lowest Calculated and Responsive Quotation and Recommending Approval

WHEREAS, the PROVINCIAL HEALTH OFFICE, NEW CAPITOL BUILDING, COGON DISTRICT, TAGBILARAN CITY, of the PROVINCIAL GOVERNMENT OF BOHOL made procurement of goods under Purchase Requests No. - PHO - 2020 - 071 re: PROCUREMENT OF OFFICE SUPPLIES AND TONER ABC of P 186,213.49;

WHEREAS, canvass of prices done in the course of the Negotiated Method of Procurement showed that GOLDEN AI TRADING offered the lowest price quotation among the suppliers as reflected in the Abstract of Bid Proposals,


WHEREAS, under Section 53.9 of the IRR of R.A. 9184 and upon careful examination, validation and verification of the accreditation and other pertinent documents of GOLDEN AI TRADING including the price quotation offered, to determine its eligibility to transact business with the Provincial Government and the responsiveness of its bid GOLDEN AI TRADING has been found to be ELIGIBLE and its bid, RESPONSIVE;

To declare GOLDEN AI TRADING as the bidder with the LOWEST CALCULATED AND RESPONSIVE QUOTATION for items no. 1, 2, 3, 4, 5, 6, 7, 8, 9, 10, 11, 12, 13, 14, 15, 16, 17, 18, 19, 20, 21, 22, 23, 24, 25, 26, 27, 28, 29, 30, 31, 32, 33, 34, 35, 36, & 37 only, in the amount of P 159,469.50 while items no. 38, 39, 40, & 41 are for Direct Mode of Procurement, for the DELIVERY OF GOODS/SERVICES under Negotiated Canvass No. - PHO - 2020 - 040.
- b.) To recommend award to GOLDEN AI TRADING in the amount of ONE HUNDRED FIFTY NINE THOUSAND FOUR HUNDRED SIXTY NINE PESOS AND 50/100 (P 159,469.50) for the delivery of goods under Negotiated Canvass No. - PHO - 2020 - 040;
- c.) To recommend for approval by the HONORABLE GOVERNOR of the PROVINCIAL GOVERNMENT OF BOHOL the foregoing findings


