





BAC Resolution Recommending the Use of Negotiated Procurement through Small Value, Declaring Lowest Calculated and Responsive Quotation and Recommending Approval

WHEREAS, the <u>PROVINCIAL HUMAN RESOURCE MANAGEMENT & DEVELOPMENT OFFICE</u> of the PROVINCIAL GOVERNMENT OF BOHOL made procurement of goods under Purchase Requests No. <u>2020-0267</u>; re; <u>Procurement of Photocopier for Payroll & Wages Preparation for use at Provincial Human Resource Management & Development Office New Capitol Compound, Tagbilaran City.</u> with an ABC of <u>P 265,000.00</u>;
