WHEREAS, in the detailed evaluation of bids, **B & J COMPUTERS AND ELECTRONICS SERVICES** was declared as the Lowest Calculated Bid as Read for item no. 1 & 2 in the amount of **P98,690.00** while **COPIER SOURCE ENTERPRISES** was declared as the Lowest Calculated Bid as Read for item no. 3 in the amount of **P 149,990.00** and were recommended for post qualification;

WHEREAS, upon the conduct of post qualification by the Technical Working Group, **B & J COMPUTERS AND ELECTRONICS SERVICES** met the required Legal, Technical and Financial requirement for the said project while **COPIER SOURCE ENTERPRISES** is failed to pass the Post Qualification Process due to the Deficiency of the specification offered;
