BAC Resolution Recommending the Use of Negotiated Procurement through Small Value, Declaring Lowest Calculated and Responsive Quotation and Recommending Approval

WHEREAS, the PROVINCIAL ENGINEER'S OFFICE of the PROVINCIAL GOVERNMENT OF BOHOL made procurement of goods under Purchase Request No. 2020-0339 fe; Procurement of Hardware & Construction Supplies for the General Repair of Sapang Dako Bridge at Monte Video, Carmen, Bohol, by the Provincial Engineer's Office, New Capitol Compound, Tagbilaran City. with an ABC of P 337,825.00;

WHEREAS, canvass of prices done in the course of the Negotiated Method of Procurement showed that <u>A&D</u> <u>CONSDTRUCTION AND SUPPLY</u> offered the lowest price quotation among the suppliers as reflected in the Abstract of Bid Quotations;

WHEREAS, under Section 53.9 of the IRR of R.A. 9184 and upon careful examination, validation and verification of the accreditation and other pertinent documents of <u>A&D CONSDTRUCTION AND SUPPLY</u> including the price quotation offered, to determine its eligibility to transact business with the Provincial Government and the responsiveness of its bid <u>A&D CONSDTRUCTION AND SUPPLY</u> has been found to be ELIGIBLE and its bid, RESPONSIVE;

- a.) To declare A&D CONSDTRUCTION AND SUPPLY as the bidder with the LOWEST CALCULATED AND RESPONSIVE BID for the DELIVERY OF GOODS/SERVICES under Negotiated Canvass No. 2020-0241;
- b.) To recommend award to <u>A&D CONSDTRUCTION AND SUPPLY</u> for the delivery of goods/services under Negotiated Canvass No. <u>2020-0241</u> in the amount of <u>P 337,820.00</u>
- c.) To recommend for approval by the HONORABLE GOVERNOR of the PROVINCIAL GOVERNMENT OF BOHOL the foregoing findings.
