WHEREAS, the OFFICE OF THE PROVINCIAL VETERINARIAN of the PROVINCIAL GOVERNMENT OF BOHOL made procurement of goods under Purchase Request No. 2020-0289 re; Procurement of Fabricated Manual Grass Cutter for the use at Office of the Provincial Veterinarian, Tagbilaran City. with an ABC of P 320,000.00;

WHEREAS, canvass of prices done in the course of the Negotiated Method of Procurement showed that STEVE STEEL FABRICATION offered the lowest price quotation among the suppliers as reflected in the Abstract of Bid Quotations;

WHEREAS, under Section 53.9 of the IRR of R.A. 9184 and upon careful examination, validation and verification of the accreditation and other pertinent documents of STEVE STEEL FABRICATION including the price quotation offered, to determine its eligibility to transact business with the Provincial Government and the responsiveness of its bid STEVE STEEL FABRICATION has been found to be ELIGIBLE and its bid, RESPONSIVE:
