BAC Resolution Recommending the Use of Negotiated Procurement through Small Value, Declaring Lowest Calculated and Responsive Quotation and Recommending Approval

WHEREAS, the GOVERNOR'S OFFICE of the PROVINCIAL GOVERNMENT OF BOHOL made procurement of goods under Purchase Requests No. 2020-001 tre; Procurement of Venetian Blinds for use at the Office of the Governor, COS, Admin, SPS & Finance Office, New Capitol Compound, Tagbilaran City. with an ABC of P 182,056.50;

WHEREAS, canvass of prices done in the course of the Negotiated Method of Procurement showed that <u>SKETCHES & PLOTS & FURNITURES & FIXTURES ENTERPRISES</u> offered the lowest price quotation among the suppliers as reflected in the Abstract of Bid Quotations;

WHEREAS, under Section 53.9 of the IRR of R.A. 9184 and upon careful examination, validation and verification of the accreditation and other pertinent documents of <u>SKETCHES & PLOTS & FURNITURES & FIXTURES ENTERPRISES</u> including the price quotation offered, to determine its eligibility to transact business with the Provincial Government and the responsiveness of its bid <u>SKETCHES & PLOTS & FURNITURES & FIXTURES ENTERPRISES</u> has been found to be ELIGIBLE and its bid, RESPONSIVE;
