WHEREAS, the **PROVINCIAL HUMAN RESOURCE MANAGEMENT & DEVELOPMENT OFFICE**, of the **PROVINCIAL GOVERNMENT OF BOHOL** made procurement of goods under Purchase Requests No. **2020-0393**; re; **Procurement of Visitor's Chair, Office Filing Cabinet, Airport Gang Chair and Office Table for use at the Provincial Human Resource Management & Development Office, Bohol Provincial Capitol Building, Cogon District, Tagbilaran City** with an ABC of **P 115,500.00**;




