WHEREAS, the OFFICE OF THE PROVINCIAL AGRICULTURIST of the PROVINCIAL GOVERNMENT OF BOHOL made procurement of goods under Purchase Requests No. 2020-0287; re; Procurement of Native/Native Crossbred Piglets for the RASS Division at the Office of the Provincial Agriculturist, New Capitol Compound, Tagbilaran City. with an ABC of P 350,000.00;



NOW, THEREFORE, We, the Members of the Bids and Awards Committee, hereby RESOLVE, as it hereby RESOLVED:




