

BAC Resolution Recommending the Use of Negotiated Procurement through Small Value, Declaring Lowest Calculated and Responsive Quotation and Recommending Approval

WHEREAS, the **PROVINCIAL HEALTH OFFICE, NEW CAPITOL BUILDING, COGON DISTRICT, TAGBILARAN CITY**, of the PROVINCIAL GOVERNMENT OF BOHOL made procurement of goods under Purchase Requests No. - PHO - 2020 - 097 re: **PROCUREMENT OF PLAQUES FOR USE OF THE NATIONAL VOLUNTARY BLOOD SERVICE PROGRAM ABC of P 225,274.00;**


WHEREAS, canvass of prices done in the course of the Negotiated Method of Procurement showed that **BLUE ARROW SIGNS AND PRINTS** offered the lowest price quotation among the suppliers as reflected in the Abstract of Bid Proposals,


WHEREAS, under Section 53.9 of the IRR of R.A. 9184 and upon careful examination, validation and verification of the accreditation and other pertinent documents of **BLUE ARROW SIGNS AND PRINTS** including the price quotation offered, to determine its eligibility to transact business with the Provincial Government and the responsiveness of its bid **BLUE ARROW SIGNS AND PRINTS** has been found to be **ELIGIBLE** and its bid, **RESPONSIVE**;

NOW, THEREFORE, We, the Members of the Bids and Awards Committee, hereby RESOLVE, as it hereby RESOLVED:

- a.) To declare **BLUE ARROW SIGNS AND PRINTS** as the bidder with the **LOWEST CALCULATED AND RESPONSIVE QUOTATION** in the amount **P 225,256.05** for the **DELIVERY OF GOODS/SERVICES** under Negotiated Canvass No. - PHO - 2020 - 062.
- b.) To recommend award to **BLUE ARROW SIGNS AND PRINTS** in the amount of **TWO HUNDRED TWENTY FIVE THOUSAND TWO HUNDRED FIFTY SIX PESOS AND 05/100 (P 225,256.05)** for the delivery of goods under Negotiated Canvass No. - PHO - 2020 - 062;
- c.) To recommend for approval by the **HONORABLE GOVERNOR** of the **PROVINCIAL GOVERNMENT OF BOHOL** the foregoing findings


