WHEREAS, the OFFICE OF THE SP - BOARD MEMBER RESTITUTO B. AUXTERO of the PROVINCIAL GOVERNMENT OF BOHOL made procurement of goods under Purchase Request No. 2020-0355, re; Procurement of Tubeless Tires, Engine Oil, Spare parts with Labor for Service Vehicle Mitsubishi Strada(Pick up Type) with Plate No. SKY-346, Assigned at the Office of the SP - Board Member Restituto B. Auxtero, Bohol Provincial Capitol Compound, Cogon District, Tagbilaran City with an ABC of P 68,525.00;

WHEREAS, canvass of prices done in the course of the Negotiated Method of Procurement showed that TAGBILARAN CITY TYRE SALES & SERVICE CENTER offered the lowest price quotation among the suppliers as reflected in the Abstract of Bid Quotations;
