



BAC Resolution Recommending the Use of Negotiated Procurement through Small Value, Declaring Lowest Calculated and Responsive Quotation and Recommending Approval

WHEREAS, the **PROVINCIAL ECONOMIC ENTERPRISE MANAGEMENT OFFICE**, of the **PROVINCIAL GOVERNMENT OF BOHOL** made procurement of goods under Purchase Requests No. 2020-0211; re; Procurement of Various Office Supplies for use at Provincial Economic Enterprise Management Office, New Capitol Site, Tagbilaran City. with an ABC of P 51,585.53;

WHEREAS, canvass of prices done in the course of the Negotiated Method of Procurement showed that **3 MSG ENTERPRISES** offered the lowest price quotation among the suppliers as reflected in the Abstract of Bid Quotations;


WHEREAS, under Section 53.9 of the IRR of R.A. 9184 and upon careful examination, validation and verification of the accreditation and other pertinent documents of **3 MSG ENTERPRISES** including the price quotation offered, to determine its eligibility to transact business with the Provincial Government and the responsiveness of its bid **3 MSG ENTERPRISES**, has been found to be **ELIGIBLE** and its bid, **RESPONSIVE**;




