WHEREAS, the **BIDS AND AWARDS COMMITTEE** passed BAC Resolution No. _____ series of 2020 re: BAC Resolution Declaring 2nd Failure of Bidding and Recommending Procurement through Negotiated Mode; and was duly approved by the Honorable Governor, authorizing the use of the such Method of Procurement by the **Provincial Health Office, New Capitol Site, Cogon District, Tagbilaran City** in undertaking Procurement Request under **PR No. – PHO – 2020 – 129** re: **PROCUREMENT OF VARIOUS LABORATORY SUPPLIES FOR USE AT THE WATER BACTERIOLOGY LABORATORY** with an ABC of **P 712,221.80**;


WHEREAS, canvass of prices done in the course of the Negotiated Method of Procurement showed that **INTEGRATED SCIENTIFIC AND INDUSTRIAL SUPPLY** offered the lowest price among the suppliers as reflected in the Abstract of Bid Proposals;


WHEREAS, upon careful examination, validation and verification of the accreditation and other pertinent documents, including the price quotation offered, to determine its eligibility to transact business with the provincial government and the responsiveness of its bid and as provided for under paragraph a of Section 53 of the implementing Rules and Regulations of R.A. 9184, **INTEGRATED SCIENTIFIC AND INDUSTRIAL SUPPLY** has been found to be **ELIGIBLE** and its bid, **RESPONSIVE**;


NOW, THEREFORE, We, the Members of the Bids and Awards Committee, hereby RESOLVE, as it hereby RESOLVED:


- a. To declare **INTEGRATED SCIENTIFIC AND INDUSTRIAL SUPPLY** as the supplier with the Lowest and Responsive Price Quotation for the Delivery of Goods under **Negotiated Canvass No. – PHO – 2020 – 113 (2nd failure of bidding)**;
- b. To recommend award **INTEGRATED SCIENTIFIC AND INDUSTRIAL SUPPLY** for the Delivery of Goods under **Negotiated Canvass No. – PHO – 2020 – 113 (2nd failure of bidding)** in the amount of **SEVEN HUNDRED SIX THOUSAND TWO HUNDRED NINETY TWO PESOS ONLY (P 706,292.00)**;
- c. To recommend for approval by the **HONORABLE GOVERNOR** of the **PROVINCIAL GOVERNMENT OF BOHOL** the foregoing findings.




