

BAC Resolution Recommending Procurement thru Negotiated Method Resulting from the Second Failure of Bidding, Declaring LCRQ and Recommending Award

WHEREAS, the BIDS AND AWARDS COMMITTEE passed BAC Resolution No. 20-0128, series of 2020 re: BAC Resolution Declaring 2nd Failure of Bidding and Recommending Procurement through Negotiated Mode; and was duly approved by the Honorable Governor, authorizing the use of the such Method of Procurement by the OFFICE OF THE PROVINCIAL AGRICULTURIST in undertaking Procurement Request under PR No. 2020-0096 re: Procurement of Farm Machineries to Increase Farm Mechanization Level in the Province to Have Access to Modern Agricultural Equipment for the Farmers, by the Office of the Provincial Agriculturist, New Capitol Site, Tagbilaran City, with an ABC of P 300,000.00.

WHEREAS, canvass of prices done in the course of the Negotiated Method of Procurement showed that JAN SURPLUS CENTER and BOHOL OVERSEA COMMERCIAL offered the lowest price quotation among the suppliers as reflected in the Abstract of Bid Quotation;

WHEREAS, upon careful examination, validation and verification of the accreditation and other pertinent documents, including the price quotation offered, to determine its eligibility to transact business with the provincial government and the responsiveness of its bid and as provided for under paragraph a of Section 53.1 of the Implementing Rules and Regulations of R.A. 9184, JAN SURPLUS CENTER AND BOHOL OVERSEA COMMERCIAL has been found to be ELIGIBLE and its bid, RESPONSIVE;

NOW, THEREFORE, We, the Members of the Bids and Awards Committee, hereby RESOLVES, as it is hereby RESOLVED:

- a). To declare JAN SURPLUS CENTER and BOHOL OVERSEA COMMERCIAL as the suppliers with the **Lowest and Responsive Price Quotation** for the Delivery of Goods/Services under Negotiated Canvass No. 2020-0130 (2nd Failure);
- b). To recommend award to JAN SURPLUS CENTER for item nos. 1-5,8,9,11 and 13-15 in the amount of P 123,674.60 and BOHOL OVERSEA COMMERCIAL for item nos. 6,7,10 and 12 in the amount of P 173,790.00 or delivery of goods/services under Negotiated Canvass No. 2020-0130 (2nd Failure);
- c). To recommend for approval by the HONORABLE GOVERNOR of the PROVINCIAL GOVERNMENT OF BOHOL the foregoing findings.
