WHEREAS, the **PROVINCIAL DISASTER RISK REDUCTION & MANAGEMENT OFFICE** of the **PROVINCIAL GOVERNMENT OF BOHOL** made procurement of goods under Purchase Request No. **2020-0270** re: **Procurement of Tires for the Various Service Vehicles & Ambulances of PDRMO - TaRSIER 117**, by the Provincial Disaster Risk Reduction & Management Office, New Capitol Compound, Tagbilaran City.. with an ABC of **P 726,400.00**;




