



BAC Resolution Recommending the Use of Negotiated Procurement through Small Value, Declaring Lowest Calculated and Responsive Quotation and Recommending Approval

WHEREAS, the PROVINCIAL HEALTH OFFICE, NEW CAPITOL BUILDING, COGON DISTRICT, TAGBILARAN CITY, of the PROVINCIAL GOVERNMENT OF BOHOL made procurement of goods under Purchase Requests No. - PHO - 2020 - 033 re: PROCUREMENT OF TUBELESS TIRES ABC of P 106,980.00;



WHEREAS, under Section 53.9 of the IRR of R.A. 9184 and upon careful examination, validation and verification of the accreditation and other pertinent documents of 200M AUTO REPAIR SHOP AND PARTS including the price quotation offered, to determine its eligibility to transact business with the Provincial Government and the responsiveness of its bid 200M AUTO REPAIR SHOP AND PARTS has been found to be ELIGIBLE and its bid, RESPONSIVE;

NOW, THEREFORE, We, the Members of the Bids and Awards Committee, hereby RESOLVE, as it hereby RESOLVED:

- a.) To declare 200M AUTO REPAIR SHOP AND PARTS as the bidder with the **LOWEST CALCULATED AND RESPONSIVE QUOTATION** in the amount P 106,880.00 for the **DELIVERY OF GOODS/SERVICES** under Negotiated Canvass No. - PHO - 2020 - 016.
- b.) To recommend award to 200M AUTO REPAIR SHOP AND PARTS in the amount of **ONE HUNDRED SIX THOUSAND EIGHT HUNDRED EIGHTY PESOS ONLY (P 106,880.00)** for the delivery of goods under Negotiated Canvass No. - PHO - 2020 - 016;
- c.) To recommend for approval by the **HONORABLE GOVERNOR** of the **PROVINCIAL GOVERNMENT OF BOHOL** the foregoing findings






