BAC Resolution Recommending the Use of Negotiated Procurement through Small Value, Declaring Lowest Calculated and Responsive Quotation and Recommending Approval

WHEREAS, the <u>PROVINCIAL HEALTH OFFICE</u>, <u>NEW CAPITOL BUILDING</u>, <u>COGON DISTRICT</u>, <u>TAGBILARAN CITY</u>, of the PROVINCIAL GOVERNMENT OF BOHOL made procurement of goods under <u>Purchase Requests No. - PHO - 2020 - 033</u> re: <u>PROCUREMENT OF TUBELESS TIRES</u> ABC of <u>P 106,980.00</u>;

WHEREAS, canvass of prices done in the course of the Negotiated Method of Procurement showed that <u>200M AUTO REPAIR SHOP AND PARTS</u> offered the lowest price quotation among the suppliers as reflected in the Abstract of Bid Proposals,

WHEREAS, under Section 53.9 of the IRR of R.A. 9184 and upon careful examination, validation and verification of the accreditation and other pertinent documents of **200M AUTO REPAIR SHOP AND PARTS** including the price quotation offered, to determine its eligibility to transact business with the Provincial Government and the responsiveness of its bid **200M AUTO REPAIR SHOP AND PARTS** has been found to be ELIGIBLE and its bid, RESPONSIVE;

- b.) To recommend award to <u>200M AUTO REPAIR SHOP AND PARTS</u> in the amount of <u>ONE HUNDRED SIX</u>

  <u>THOUSAND EIGHT HUNDRED EIGHTY PESOS ONLY (P 106,880.00)</u> for the delivery of goods under <u>Negotiated Canvass No. PHO 2020 016</u>;
- c.) To recommend for approval by the HONORABLE GOVERNOR of the PROVINCIAL GOVERNMENT OF BOHOL the foregoing findings
