## RESOLUTION NO. 20-0366 Series of 2020

WHEREAS, the <u>PROVINCIAL ENGINEER'S OFFICE</u> of the PROVINCIAL GOVERNMENT OF BOHOL made procurement of goods under Purchase Requests No. <u>2020-0265</u>, re; <u>Procurement of Vehicle Spare Parts, Tires with Labor for the Service Vehicle Mit.</u> <u>Strada at the Provincial Engineer's Office, New Capitol Compound, Tagbilaran City.</u> with an ABC of <u>P 211,170.00</u>;

WHEREAS, canvass of prices done in the course of the Negotiated Method of Procurement showed that <u>CARE AUTOHAUS</u> offered the lowest price quotation among the suppliers as reflected in the Abstract of Bid Quotations;
