WHEREAS, the BIDS AND AWARDS COMMITTEE passed BAC Resolution No. 19-1125 series of 2019 re: BAC Resolution Declaring 2<sup>nd</sup> Failure of Bidding and Recommending Procurement through Negotiated Mode; and was duly approved by the Honorable Governor, authorizing the use of the such Method of Procurement by the OFFICE OF THE PROVINCIAL AGRICULTURIST/HVCDP UNIT in undertaking Procurement Request under PR No. 2019-0862 re: Procurement of Ubi Tubers for Distribution to the Farmers in Support to the Production Enhancement of Ubi High Value Commercial Crops in the Province of Bohol, by the Office of the Provincial Agriculturist, New Capitol Site, Tagbilaran City, with an ABC of ₱ 2,149,990.00;

WHEREAS, canvass of prices done in the course of the Negotiated Method of Procurement showed that LA SUERTA'S FRUIT TREES NURSERY offered the lowest price quotation among the suppliers as reflected in the Abstract of Bid Quotation;

WHEREAS, upon careful examination, validation and verification of the accreditation and other pertinent documents, including the price quotation offered, to determine its eligibility to transact business with the provincial government and the responsiveness of its bid and as provided for under paragraph a of Section 53.1 of the Implementing Rules and Regulations of R.A. 9184, LA SUERTA'S FRUIT TREES NURSERY has been found to be ELIGIBLE and its bid, RESPONSIVE;


NOW, THEREFORE, We, the Members of the Bids and Awards Committee, hereby RESOLVES, as it is hereby RESOLVED:




