
WHEREAS, canvass of prices done in the course of the Negotiated Method of Procurement showed that **FIRST BAY PHARMA DISTRIBUTOR** offered the lowest price among the suppliers as reflected in the Abstract of Bid Proposals;

WHEREAS, upon careful examination, validation and verification of the accreditation and other pertinent documents, including the price quotation offered, to determine its eligibility to transact business with the provincial government and the responsiveness of its bid and as provided for under paragraph a of Section 53 of the implementing Rules and Regulations of R.A. 9184, **FIRST BAY PHARMA DISTRIBUTOR** has been found to be **ELIGIBLE** and its bid, **RESPONSIVE**;


NOW, THEREFORE, We, the Members of the Bids and Awards Committee, hereby RESOLVE, as it hereby RESOLVED:

- a. To declare **FIRST BAY PHARMA DISTRIBUTOR** as the supplier with the Lowest and Responsive Price Quotation for the Delivery of Goods for items no. 4 & 7 only in the amount of **SIXTY SEVEN THOUSAND EIGHT HUNDRED FIFTY PESOS ONLY (P 67,850.00)** while item no. 1 having no quotation from the supplier(s) are recommended for cancellation of Purchase Request, under **Negotiated Canvass No. – PHO – 19 – 140 (2<sup>nd</sup> Failure of Bidding)**;
- b. To recommend award **FIRST BAY PHARMA DISTRIBUTOR** for the Delivery of Goods under **Negotiated Canvass No. – PHO – 19 – 140 (2<sup>nd</sup> Failure of Bidding)** in the amount of **SIXTY SEVEN THOUSAND EIGHT HUNDRED FIFTY PESOS ONLY (P 67,850.00)**;
- c. To recommend for approval by the **HONORABLE GOVERNOR** of the **PROVINCIAL GOVERNMENT OF BOHOL** the foregoing findings.


