WHEREAS, the BIDS AND AWARDS COMMITTEE passed BAC Resolution No. \_\_\_\_\_ series of 2020 re: BAC Resolution Declaring 2nd Failure of Bidding and Recommending Procurement through Negotiated Mode; and was duly approved by the Honorable Governor, authorizing the use of the such Method of Procurement by the FRANCISCO DAGOHOY MUNICIPAL HOSPITAL, INABANGA, BOHOL in undertaking Procurement Request under PR No. - PHO - 2020 - 030 re: PROCUREMENT OF FIRE EXTINGUISHER FOR USE TO EXTINGUISH OR CONTROL FIRES IN EMERGENCY SITUATIONS with an ABC of P 36,000.00;

WHEREAS, canvass of prices done in the course of the Negotiated Method of Procurement showed that 3 MSG ENTERPRISES offered the lowest price among the suppliers as reflected in the Abstract of Bid Proposals;


WHEREAS, upon careful examination, validation and verification of the accreditation and other pertinent documents, including the price quotation offered, to determine its eligibility to transact business with the provincial government and the responsiveness of its bid and as provided for under paragraph a of Section 53 of the implementing Rules and Regulations of R.A. 9184, 3 MSG ENTERPRISES has been found to be ELIGIBLE and its bid, RESPONSIVE;


NOW, THEREFORE, We, the Members of the Bids and Awards Committee, hereby RESOLVE, as it hereby RESOLVED:



- b. To recommend award 3 MSG ENTERPRISES for the Delivery of Goods under Negotiated Canvass No. - PHO - 2020 - 051 (2<sup>nd</sup> failure of bidding) in the amount of THIRTY FIVE THOUSAND EIGHT HUNDRED FIFTY PESOS ONLY (P 35,850.00);
- c. To recommend for approval by the HONORABLE GOVERNOR of the PROVINCIAL GOVERNMENT OF BOHOL the foregoing findings.
