WHEREAS, the CONG. SIMEON G. TORIBIO MEMORIAL HOSPITAL, CARMEN, BOHOL, of the PROVINCIAL GOVERNMENT OF BOHOL made procurement of goods under Purchase Requests No. - PHO - 2020 - 180 re: PROCUREMENT OF VARIOUS MEDICAL SUPPLIES with an ABC of P 412,100.00;


WHEREAS, canvass of prices done in the course of the Negotiated Method of Procurement showed that DEXTEL TRADING offered the lowest price quotation among the suppliers as reflected in the Abstract of Bid Proposals,

- c.) To recommend for approval by the HONORABLE GOVERNOR of the PROVINCIAL GOVERNMENT OF BOHOL the foregoing findings
