WHEREAS, the PROVINCIAL ENGINEER'S OFFICE of the PROVINCIAL GOVERNMENT OF BOHOL made procurement of goods under Purchase Requests No. 2020-0269; re; Procurement of Vehicle Spare Parts with Labor for the Service Vehicle Mit. Strada at the Provincial Engineer's Office, New Capitol Compound, Tagbilaran City. with an ABC of P 305,800.00;

WHEREAS, canvass of prices done in the course of the Negotiated Method of Procurement showed that CARE AUTOHAUS offered the lowest price quotation among the suppliers as reflected in the Abstract of Bid Quotations;
