



BAC Resolution Recommending the Use of Negotiated Procurement through Small Value, Declaring Lowest Calculated and Responsive Quotation and Recommending Approval

WHEREAS, the **PROVINCIAL ENGINEER'S OFFICE** of the **PROVINCIAL GOVERNMENT OF BOHOL** made procurement of goods under Purchase Requests No. 2020-0269; re; Procurement of Vehicle Spare Parts with Labor for the Service Vehicle Mit. Strada at the Provincial Engineer's Office, New Capitol Compound, Tagbilaran City. with an ABC of P 305,800.00;

WHEREAS, canvass of prices done in the course of the Negotiated Method of Procurement showed that **CARE AUTOHAUS** offered the lowest price quotation among the suppliers as reflected in the Abstract of Bid Quotations;






