



BAC Resolution Recommending the Use of Negotiated Procurement through Small Value, Declaring Lowest Calculated and Responsive Quotation and Recommending Approval

WHEREAS, the CONG. SIMEON G. TORIBIO MEMORIAL HOSPITAL, CARMEN, BOHOL, of the PROVINCIAL GOVERNMENT OF BOHOL made procurement of goods under Purchase Requests No. - PHO - 2020 - 179 re: **PROCUREMENT FOR FABRICATION OF CABINETS FOR OPD, RECORD SECTION, ADMIN OFFICE, WARD, & STOCKROOM with an ABC of **P 89,947.50**;**

NOW, THEREFORE, We, the Members of the Bids and Awards Committee, hereby RESOLVE, as it hereby RESOLVED:



- b.) To recommend award to **BQ BUILDERWARE** in the amount of **EIGHTY TWO THOUSAND NINE HUNDRED FORTY TWO PESOS AND 50/100 (P 82,942.50)** for the delivery of goods under Negotiated Canvass No. - PHO - 2020 - 130;
- c.) To recommend for approval by the **HONORABLE GOVERNOR** of the **PROVINCIAL GOVERNMENT OF BOHOL** the foregoing findings






