WHEREAS, the OFFICE OF THE GOVERNOR, of the PROVINCIAL GOVERNMENT OF BOHOL made procurement of goods under Purchase Requests No. 2020-0309; re; Procurement of I.T Equipment for the use at Office of the Governor, New Capitol Compound, Tagbilaran City. with an ABC of P 99,550.00;
