



BAC Resolution Recommending the Use of Negotiated Procurement through Small Value, Declaring Lowest Calculated and Responsive Quotation and Recommending Approval

WHEREAS, the PROVINCIAL HEALTH OFFICE, NEW CAPITOL BUILDING, COGON DISTRICT, TAGBILARAN CITY, of the PROVINCIAL GOVERNMENT OF BOHOL made procurement of goods under Purchase Requests No. - PHO - 2020 - 027 re: PROCUREMENT OF HIGH QUALITY POLYESTER VEST with an ABC of P 90,000.00;


WHEREAS, canvass of prices done in the course of the Negotiated Method of Procurement showed that 3 MSG ENTERPRISES offered the lowest price quotation among the suppliers as reflected in the Abstract of Bid Proposals,


WHEREAS, under Section 53.9 of the IRR of R.A. 9184 and upon careful examination, validation and verification of the accreditation and other pertinent documents of 3 MSG ENTERPRISES including the price quotation offered, to determine its eligibility to transact business with the Provincial Government and the responsiveness of its bid 3 MSG ENTERPRISES has been found to be **ELIGIBLE** and its bid, **RESPONSIVE**;


NOW, THEREFORE, We, the Members of the Bids and Awards Committee, hereby **RESOLVE**, as it hereby **RESOLVED**:

- b.) To recommend award to 3 MSG ENTERPRISES in the amount of **EIGHTY NINE THOUSAND FIVE HUNDRED PESOS ONLY (P 89,500.00)** for the delivery of goods under Negotiated Canvass No. - PHO - 2020 - 014;
- c.) To recommend for approval by the **HONORABLE GOVERNOR** of the **PROVINCIAL GOVERNMENT OF BOHOL** the foregoing findings
