WHEREAS, the **OFFICE OF THE PROVINCIAL VETERINARIAN** of the PROVINCIAL GOVERNMENT OF BOHOL made procurement of goods under Purchase Requests No. 2019-0291; re; Procurement of Pond Liners, by the Office of the Provincial Veterinarian, New Capitol Compound, Tagbilaran City. with an ABC of P 500,000.00;

WHEREAS, canvass of prices done in the course of the Negotiated Method of Procurement showed that **LEZAR TRADING** offered the lowest price quotation among the suppliers as reflected in the Abstract of Bid Quotations;


WHEREAS, under Section 53.9 of the IRR of R.A. 9184 and upon careful examination, validation and verification of the accreditation and other pertinent documents of **LEZAR TRADING** including the price quotation offered, to determine its eligibility to transact business with the Provincial Government and the responsiveness of its bid **LEZAR TRADING** has been found to be ELIGIBLE and its bid, RESPONSIVE;


NOW, THEREFORE, We, the Members of the Bids and Awards Committee, hereby RESOLVE, as it hereby RESOLVED:

- a.) To declare **LEZAR TRADING** as the bidder with the **LOWEST CALCULATED AND RESPONSIVE BID** for the **DELIVERY OF GOODS/SERVICES** under Negotiated Canvass No. 2020-0192;
- b.) To recommend award to **LEZAR TRADING** for the delivery of goods/services under Negotiated Canvass No. 2020-0192 in the amount of P 498,750.00;
- c.) To recommend for approval by the **HONORABLE GOVERNOR** of the **PROVINCIAL GOVERNMENT OF BOHOL** the foregoing findings.




