WHEREAS, the PROVINCIAL HEALTH OFFICE of the PROVINCIAL GOVERNMENT OF BOHOL made procurement under Purchase Request No. 2020-C-092 re: PROVISION OF MEALS AND SNACKS INCLUDING ACCOMMODATION FOR THE CONDUCT OF MATERNAL/ NEONATAL DEATH REVIEW FOR THE RECIPIENTS AND HEALTH PROVIDERS AND CONSULTATIVE MEETING WITH STAKEHOLDERS with an ABC of ₱ 208, 775.00;


