WHEREAS, the PROVINCIAL LEGAL OFFICE of the PROVINCIAL GOVERNMENT OF BOHOL made procurement of goods under Purchase Request No. 2020-0181; re; Procurement of Multi-Function printer & All-in-One Ecotank Printer for use at Provincial Legal Office, New Capitol Compound, Tagbilaran City. with an ABC of P 52,000.00;

WHEREAS, canvass of prices done in the course of the Negotiated Method of Procurement showed that B&J COMPUTER AND ELECTRONICS SERVICES offered the lowest price quotation among the suppliers as reflected in the Abstract of Bid Quotations;


