BAC Resolution Recommending the Use of Negotiated Procurement through Small Value, Declaring Lowest Calculated and Responsive Quotation and Recommending Approval

WHEREAS, the <u>PROVINCIAL LEGAL OFFICE</u> of the PROVINCIAL GOVERNMENT OF BOHOL made procurement of goods under Purchase Request No. <u>2020-0181</u>; re; <u>Procurement of Multi-Function printer & All-in-One Ecotank Printer for use at Provincial Legal Office, New Capitol Compound, Tagbilaran City.</u> with an ABC of <u>P 52,000.00</u>;

WHEREAS, canvass of prices done in the course of the Negotiated Method of Procurement showed that <u>B&J COMPUTER AND</u> <u>ELECTRONICS SERVICES</u> offered the lowest price quotation among the suppliers as reflected in the Abstract of Bid Quotations;

WHEREAS, under Section 53.9 of the IRR of R.A. 9184 and upon careful examination, validation and verification of the accreditation and other pertinent documents of B&J COMPUTER AND ELECTRONICS SERVICES. Including the price quotation offered, to determine its eligibility to transact business with the Provincial Government and the responsiveness of its bid B&J COMPUTER AND ELECTRONICS SERVICES. has been found to be ELIGIBLE and its bid, RESPONSIVE;
