**WHEREAS**, the **CONG. NATALIO P. CASTILLO SR. MEMORIAL HOSPITAL, LOON, BOHOL**, of the **PROVINCIAL GOVERNMENT OF BOHOL** made procurement of goods under **Purchase Requests No. - PHO - 2020 - 141 re: PROCUREMENT OF PLASTIC CHAIR & PLASTIC BENCH** with an ABC of **P 100,000.00**;

**WHEREAS**, canvass of prices done in the course of the Negotiated Method of Procurement showed that **DELMA ENTERPRISES** offered the lowest price quotation among the suppliers as reflected in the Abstract of Bid Proposals,

**WHEREAS**, under Section 53.9 of the IRR of R.A. 9184 and upon careful examination, validation and verification of the accreditation and other pertinent documents of **DELMA ENTERPRISES** including the price quotation offered, to determine its eligibility to transact business with the Provincial Government and the responsiveness of its bid **DELMA ENTERPRISES** has been found to be **ELIGIBLE** and its bid, **RESPONSIVE**;

**NOW, THEREFORE**, We, the Members of the Bids and Awards Committee, hereby **RESOLVE**, as it hereby **RESOLVED**:

- b.) To recommend award to **DELMA ENTERPRISES** in the amount of **NINETY NINE THOUSAND SIX HUNDRED FIFTY PESOS ONLY (P 99,650.00)** for the delivery of goods under **Negotiated Canvass No. - PHO - 2020 - 096**;
- c.) To recommend for approval by the **HONORABLE GOVERNOR** of the **PROVINCIAL GOVERNMENT OF BOHOL** the foregoing findings
