BAC Resolution Recommending the Use of Negotiated Procurement through Small Value, Declaring Lowest Calculated and Responsive Quotation and Recommending Approval

WHEREAS, the <u>CONG. NATALIO P. CASTILLO SR. MEMORIAL HOSPITAL</u>, <u>LOON</u>, <u>BOHOL</u>, of the PROVINCIAL GOVERNMENT OF BOHOL made procurement of goods under <u>Purchase Requests No. - PHO - 2020 - 141</u> re: <u>PROCUREMENT OF PLASTIC CHAIR & PLASTIC BENCH</u> with an ABC of <u>P 100,000.00</u>;

WHEREAS, canvass of prices done in the course of the Negotiated Method of Procurement showed that <u>DELMA</u> <u>ENTERPRISES</u> offered the lowest price quotation among the suppliers as reflected in the Abstract of Bid Proposals,

NOW, THEREFORE, We, the Members of the Bids and Awards Committee, hereby RESOLVE, as it hereby RESOLVED:

- b.) To recommend award to <u>DELMA ENTERPRISES</u> in the amount of <u>NINETY NINE THOUSAND SIX</u> <u>HUNDRED FIFTY PESOS ONLY (P 99,650.00)</u> for the delivery of goods under <u>Negotiated Canvass No. PHO 2020 096</u>;
- c.) To recommend for approval by the HONORABLE GOVERNOR of the PROVINCIAL GOVERNMENT OF BOHOL the foregoing findings
