**WHEREAS**, the BIDS AND AWARDS COMMITTEE passed BAC Resolution No. 20-0436 series of 2020 re: BAC Resolution Declaring 2<sup>nd</sup> Failure of Bidding and Recommending Procurement through Negotiated Mode; and was duly approved by the Honorable Governor, authorizing the use of the such Method of Procurement by the OFFICE OF THE GOVERNOR in undertaking Procurement Request under PR No. 2019-0017 re: Procurement of Filing Rack for the use at the Records Section & Finance Section, by the Office of the Governor, New Capitol Site, Tagbilaran City, with an ABC of P 291,384.00.
