WHEREAS, the PROVINCIAL ACCOUNTING OFFICE, of the PROVINCIAL GOVERNMENT OF BOHOL made procurement of goods under Purchase Requests No. 2020-0382; re; Procurement of various Office and Janitorial Supplies for use at the Provincial Accounting Office, Bohol Provincial Capitol Building, Cogon District, Tagbilaran City with an ABC of

WHEREAS, canvass of prices done in the course of the Negotiated Method of Procurement showed that 3 MSG ENTERPRISES offered the lowest price quotation among the suppliers as reflected in the Abstract of Bid Quotations;

WHEREAS, under Section 53.9 of the IRR of R.A. 9184 and upon careful examination, validation and verification of the accreditation and other pertinent documents of <u>3 MSG ENTERPRISES</u> including the price quotation offered, to determine its eligibility to transact business with the Provincial Government and the responsiveness of its bid <u>3 MSG ENTERPRISES</u> has been found to be ELIGIBLE and its bid, RESPONSIVE;
