WHEREAS, the PROVINCIAL ENGINEER'S OFFICE of the PROVINCIAL GOVERNMENT OF BOHOL made procurement of goods under Purchase Request No. 2020-0410; re; Procurement of Various Spare Parts with Labor for the Service Vehicle of the Provincial Engineer's Office, New Capitol Compound, Tagbilaran City. with an ABC of P 109,450.00;

WHEREAS, canvass of prices done in the course of the Negotiated Method of Procurement showed that TAGBILARAN CITY TYRE SALES & SERVICE CENTER offered the lowest price quotation among the suppliers as reflected in the Abstract of Bid Quotations;
