



**BAC Resolution Recommending the Use of Negotiated Procurement through Small Value, Declaring Lowest Calculated and Responsive Quotation and Recommending Approval**

**WHEREAS**, the **PROVINCIAL ENGINEER'S OFFICE** of the **PROVINCIAL GOVERNMENT OF BOHOL** made procurement of goods under Purchase Request No. **2020-0410**; re; **Procurement of Various Spare Parts with Labor for the Service Vehicle of the Provincial Engineer's Office, New Capitol Compound, Tagbilaran City.** with an ABC of **P 109,450.00**;

**WHEREAS**, canvass of prices done in the course of the Negotiated Method of Procurement showed that **TAGBILARAN CITY TYRE SALES & SERVICE CENTER** offered the lowest price quotation among the suppliers as reflected in the Abstract of Bid Quotations;

**WHEREAS**, under Section 53.9 of the IRR of R.A. 9184 and upon careful examination, validation and verification of the accreditation and other pertinent documents of **TAGBILARAN CITY TYRE SALES & SERVICE CENTER** including the price quotation offered, to determine its eligibility to transact business with the Provincial Government and the responsiveness of its bid **TAGBILARAN CITY TYRE SALES & SERVICE CENTER** has been found to be **ELIGIBLE** and its bid, **RESPONSIVE**;

**NOW, THEREFORE**, We, the Members of the Bids and Awards Committee, hereby **RESOLVE**, as it hereby **RESOLVED**:

- b.) To recommend award to **TAGBILARAN CITY TYRE SALES & SERVICE CENTER** for the delivery of goods/services under Negotiated Canvass No. **2020-0293** in the amount of **P 85,004.00** except items no. **2,3,7 & 11**;
- c.) To recommend for approval by the **HONORABLE GOVERNOR** of the **PROVINCIAL GOVERNMENT OF BOHOL** the foregoing findings.
