BAC Resolution Recommending the Use of Negotiated Procurement through Small Value, Declaring Lowest Calculated and Responsive Quotation and Recommending Approval

WHEREAS, the **PROVINCIAL TREASURY OFFICE** of the **PROVINCIAL GOVERNMENT OF BOHOL** made procurement of goods under Purchase Requests No. **2020-0370**; re: **Procurement of Sticker Printing Services for use at the Provincial Treasury Office, New Capitol Compound, Tagbilaran City..** with an ABC of **P 117,000.00**;

WHEREAS, canvass of prices done in the course of the Negotiated Method of Procurement showed that **ST. JUDE PRESS MARKETING AND SUPPLIES** offered the lowest price quotation among the suppliers as reflected in the Abstract of Bid Quotations;


WHEREAS, under Section 53.9 of the IRR of R.A. 9184 and upon careful examination, validation and verification of the accreditation and other pertinent documents of **ST. JUDE PRESS MARKETING AND SUPPLIES** including the price quotation offered, to determine its eligibility to transact business with the Provincial Government and the responsiveness of its bid **ST. JUDE PRESS MARKETING AND SUPPLIES** has been found to be **ELIGIBLE** and its bid, **RESPONSIVE**;

- b.) To recommend award to **ST. JUDE PRESS MARKETING AND SUPPLIES** for the delivery of goods/services under Negotiated Canvass No. **2020-0266** in the amount of **P 116,415.00**;
- c.) To recommend for approval by the **HONORABLE GOVERNOR** of the **PROVINCIAL GOVERNMENT OF BOHOL** the foregoing findings.


