
**WHEREAS**, canvass of prices done in the course of the Negotiated Method of Procurement showed that GOLDEN AI TRADING offered the lowest price quotation among the suppliers as reflected in the Abstract of Bid Quotations;


**WHEREAS**, under Section 53.9 of the IRR of R.A. 9184 and upon careful examination, validation and verification of the accreditation and other pertinent documents of GOLDEN AI TRADING including the price quotation offered, to determine its eligibility to transact business with the Provincial Government and the responsiveness of its bid GOLDEN AI TRADING has been found to be **ELIGIBLE** and its bid, **RESPONSIVE**;




