

BAC Resolution Recommending Procurement thru Negotiated Method Resulting from the Second Failure of Bidding, Declaring LCRQ and Recommending Award

WHEREAS, the BIDS AND AWARDS COMMITTEE passed BAC Resolution No. 20-0981 series of 2020 re: BAC Resolution Declaring 2nd Failure of Bidding and Recommending Procurement through Negotiated Mode; and was duly approved by the Honorable Governor, authorizing the use of the such Method of Procurement by the PROVINCIAL MOTOR POOL OFFICE in undertaking Procurement Request under PR No. 2019-0615 re: Procurement of Brand New Pick-Up Vehicle for the Use at the Provincial Motor Pool New Capitol Compound, Tagbilaran City. with an ABC of P 1,400,000.00.

WHEREAS, canvass of prices done in the course of the Negotiated Method of Procurement showed that <a href="TOYOTA">TOYOTA</a>
TAGBILARAN CITY offered the lowest price quotation among the suppliers as reflected in the Abstract of Bid Quotation;

WHEREAS, upon careful examination, validation and verification of the accreditation and other pertinent documents, including the price quotation offered, to determine its eligibility to transact business with the provincial government and the responsiveness of its bid and as provided for under <u>paragraph a of Section 53.1 of the Implementing Rules and Regulations of R.A. 9184, TOYOTA TAGBILARAN CITY</u> has been found to be ELIGIBLE and its bid, RESPONSIVE;

NOW, THEREFORE, We, the Members of the Bids and Awards Committee, hereby RESOLVES, as it is hereby RESOLVED:

- a). To declare <u>TOYOTA TAGBILARAN CITY</u> as the suppliers with the Lowest Calculated and Responsive Price Quotation for the Delivery of Goods/Services under Negotiated Canvass No. <u>19-0471 (2nd Failure)</u>;
- b). To recommend award to <u>TOYOTA TAGBILARAN CITY</u> in the amount of <u>P 1,366,406.00</u> of delivery of goods/services under Negotiated Canvass No. <u>19-0471 (2nd Failure)</u>;

To recommend for approval by the HONORABLE GOVERNOR of the PROVINCIAL GOVERNMENT OF BOHOL the foregoing findings.
