

BAC Resolution Declaring LCRQ and Recommending Award

WHEREAS, the OFFICE OF THE PROVINCIAL AGRICULTURIST of the PROVINCIAL GOVERNMENT OF BOHOL made procurement under Purchase Request No. 2020-0489 re: PROCUREMENT OF LABOR AND MATERIALS FOR THE CONSTRUCTION OF DORMITORY WITH VERMIHOUSE with an ABC of ₱ 500,000.00;

NOW, THEREFORE, We, the Members of the Bids and Awards Committee, hereby RESOLVE, as it is hereby RESOLVED:


